

## NOTIFICATION

### Re : Grant of Scholarship and Cash Awards

It is notified for information of all concerned, that Scholarship/Cash Awards for the academic year 2024-25 will be granted to the children, dependents of Shareholders and Shareholders who have been enrolled as a member before the result of the concerned examination and continue as a member on the day of submission of application form for the Courses as under :

#### **Scholarship for Diploma/Degree Courses.**

1. **Degree/Diploma** in Engineering Course or equivalent courses in India approved by a recognized University/State Technical Education Board and All India Council for Technical Education & Degree in Engineering Course or equivalent courses in Foreign approved by the recognized Universities in Foreign countries.
2. **Medical/Health Science** Courses or equivalent courses approved by a recognized University and Indian Medical Council.
3. **L.L.B.** Course of 5 years after 12<sup>th</sup> std. – admission sought through 'COMMON LAW ADMISSION TEST' i.e. CLAT only.

#### **Criteria to be observed while sanctioning the Scholarship/Cash Award Cases:**

1. **SSC (X)/HSC(XII)** passed in 1<sup>st</sup> attempt- Amount of Cash Award is Rs.1000/- to Rs.2500/-. In case of Blind, Rs. 10,000/- on passing with 50% marks.
2. **Graduation** Courses should be of minimum 3 years or 6 Semesters after HSC/XII, Amount of scholarship is Rs.2500/- awarded on completion of graduation with 60% marks. In case of Blind, Rs. 10,000/- on passing.
3. **Post-Graduation** courses should be of minimum 2 years after Graduation/Degree. Amount of Scholarship is Rs.3500/- awarded on completion of Post graduation with 60% marks. In case of Blind, Rs.10,000/- on passing.
4. **Diploma** courses should be of minimum 3 years or 6 Semesters after S.S.C. or equivalent examination.
5. **Diploma** courses after HSC with two/three years are also eligible for Scholarship.
6. **Degree** courses should be of at least 4 years or 8 Semesters after H.S.C. or equivalent examination.
7. Two semesters will be considered as one academic year and the grant of Scholarship will be for each academic year on passing.
8. **ATKT** not eligible.
9. One time Scholarship of Rs. 10,000/- will be granted after successful completion of **Chartered Accountant and Company Secretary** Courses.

These benefits are only extended to Railway employees, who became Shareholders of the Society before the results of the concerned Examinations and are continued as a member on the day of submission of application form and are regular in subscribing to the Compulsory Monthly Thrift Deposit Scheme of the Society and in repayment of their Loan installments, if any.

- A Bonafide Certificate from the Institution stating the name and duration of the course and academic year in which the Student is presently studying.
- Certified/attested copy of the Mark sheet, of the last Examination in the academic year 2024-2025 (In case of Semester system, both the semesters' mark sheets are required)
- Declaration of the dependency from the shareholder.
